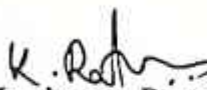

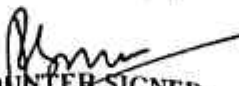

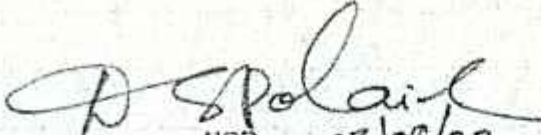

- **Supporting the institution in Industrial Interface, Community Service Projects, Internships for students, Placement Drives and related trainings.**
- **Campus training programmes for Faculty Development on Teaching Learning Technologies.**

The parties anticipate that a number of these initiatives will occur during the period of this Memorandum of Understanding (MoU).
