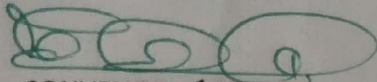
Filed grievance on 25-03-2023 requesting to provide one more hour for computer coaching given in the college. Provided one more hour from 29-03-2023.

Filed a grievance on 22-12-2022 requesting to provide a few more tube lights in room no -1. Provide 2 more tube lights in room no-1 the very next day.

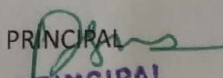
Field a grievance on 10-08-2022 requesting to clear the rain water from the college campus...

Grievance and Redressal:

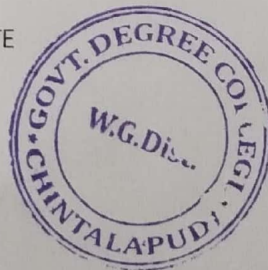
Field a grievance on 31-01-2022 with request to provide canteen facility. Committee arranged a canteen facility at back side of the staff room on 31-02-2022.

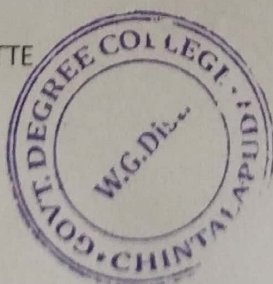

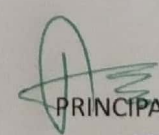

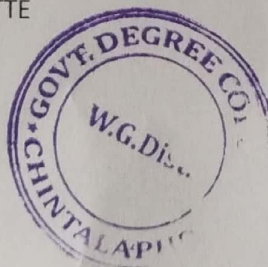
