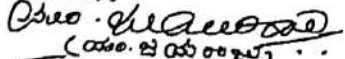
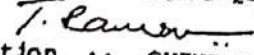

ARTICLES OF ASSOCIATION

1. Name of the Association : DEGREE COLLEGE OLD STUDENTS
ASSOCIATION - GHINTHALAPUDI
2. Location of Office : Door Number: 12-72
Ashram Street, L.M.B. Road,
CHINTHALAPUDI, W.G.Dt.
3. Activities : Welfare Activities

4. MEMBERSHIP :

- a) Eligibility : The membership shall be open to all who are interested in promoting the Society subject to the approval of the Committee. The area of Operation of the society shall be throughout India.
- b) Admission : Any person who wants to admit as member shall pay an amount of Rs. 500/- towards Admission Fee.
- c) Withdrawal & Termination of :
 - (1) Who resigns in writing;
 - (2) Who fails to attend three consecutive meetings;
 - (3) Who were expelled by the Executive Committee.

Those who forfeited their membership, thus, can rejoin as member after approval of the Committee.

5. GENERAL BODY :

- a) Meetings: The General Body meeting will be held in the month of AUGUST every year. The General Body shall meet at least once in a year.
- b) Quorum : The quorum for General Body meeting and Executive Committee meeting shall be 3/5ths.
- c) Functions and Responsibilities :
 - (1) To elect or confirm the Executive Committee
 - (2) To pass the Budget and approve the Annual report;
 - (3) To transact any other matter for the benefit of the Society;
 - (4) Auditors: To appoint an Auditor to audit the accounts of the society.
- d) The General Body shall elect the office bearers and the Committee members once in 2 years.
- e) The General Body has power to remove any member of the Executive Committee.

6. EXECUTIVE COMMITTEE :

The Executive Committee shall consists of 9 members; ie., President, Vice-Presidents, Secretary, Joint Secretary, Treasurer and 3 Executive Committee members. Any interim vacancy in the Managing Committee shall be filled up by the Committee itself. A member who has completed a term as an elected member is eligible for re-election as a member of the Committee.

The Executive Committee shall meet once in Three months. The Executive Committee shall convene a general body meeting within 30 days of receipt of a requisition for convening a meeting signed by atleast 3/5ths of the members of the society and any such requisition shall contain the proposed agenda and the reasons for such meeting. Every resolution of General Body and Executive Committee shall be recorded in the minutes book. Such minutes shall be communicated to all the members invited for the meeting within 30 days. The minutes so recorded shall be signed by the person who chaired the said meeting. The Executive Committee shall have the following powers also :-
To fix the remuneration and allowances to the employees, to appoint, dismiss, suspend or otherwise punish any employees of the society, to accept the resignations of members, to sanction all the contingent expenditure, to open administrative/branch offices, Sub-committees and institutions wherever it is felt necessary in India, to keep the funds of the society and to borrow money from the Nationalised Banks, Co-operative Banks, Private Banks, Post Offices or organisations any where, inspect the accounts periodically, transact any other matter for the benefit of the Society. All transactions of the society shall be carried out in the name of Society. The entire establishment of the Society shall be under the immediate supervision and control of the Executive Committee. To expel any member without assigning any reason therefor. To receive the subscriptions, donations, grants, gifts by way of movable or immovable properties relates to India or abroad. To acquire movable and immovable properties dispose them or give it to lease or rents for the benefit of the Society. Cheques for withdrawal of funds shall be signed by the president and Secretary jointly.

7. RESPONSIBILITIES OF OFFICE BEARERS ::

PRESIDENT :

He shall preside over all the meetings of the Society. He shall have casting vote in case of tie in the meetings. He will keep the best contact with the society. He shall closely watch the administrative and other measures and initiate suitable action whenever necessary. He will be the Chief Supervision and controlling officer of the society. He will be the constitutional head of the society.

VICE-PRESIDENT :

He will assist the President in the affairs of the Society. In the absence of the President, he will attend to the duties of the President.

SECRETARY :

He shall convene all the meetings of the society. He shall be responsible for carrying into effect, the resolutions of the General Body as well as the Executive Committee. He shall maintain proper records of the society keep them same. He shall prepare the Annual report of the society and place the same before the Annual General Body meeting for approval.

JOINT SECRETARY :

He will assist the Secretary in the affairs of the Society. In the absence of the Secretary, he will attend to the duties of the Secretary. He will see that all members attending to the meetings and get them successful.

TREASURER :

The Treasurer is to keep the regular accounts of Income and Expenditure of the Society. He will prepare the annual budget of the society and place it before the Annual General Body meeting for approval.

COMMITTEE MEMBERS :

They will attend to the activities of the Society, and strive for its development.

8. FINANCES - FUNDS :

The amounts relating to subscriptions, donations, grants, gifts movable or immovable properties shall be treated as sources of finance. Such funds shall be spent only for the attainment of the objects of the society and no portion thereof shall be transferred directly or indirectly to any of its members through any means.

9. MORTGAGES & CHARGES :

The Society shall keep a register of mortgages and charges and enter therein all mortgages, charges affecting the property of the Society and be open during the business hours to the inspection of any member or creditor of the Society without payment of any fee therefor. Any debts, liabilities relates to Society will be held pending, that can be settled by personally or by the Executive committee mutually.

10. DISPUTES :

In the event of any disputes, arising among the committee or the members of the Society, in respect of any matter relating to the affairs of the society. Any member of the society may proceed with the dispute under the provisions as mentioned in A.P.S.R.Act.

11. DISSOLUTION :

If for any reason, the society will have to be dissolved, it shall be approved through a special resolution. If upon the dissolution of any society, there remains after the satisfaction of all its debts and liabilities, any property the same shall not be delivered to or distributed among the members of the Society or any of them, but shall be delivered to some other society with a similar objective to be named by a special resolution, or in a default thereof, by the Court subject to the conditions mentioned in the Sections 24 & 25 of the Act.

12. SPECIAL RESOLUTIONS - AMENDMENTS :

By a special resolution, the Society may alter the provisions of the Memorandum and Bye-laws i.e., (1) Change of objectives of the society (2) Change of name of the Society (3) Amalgamate itself with any other society, or of (4) to divide itself in to two or more societies subject to the provisions of the Act and conditions contained in the Memorandum of Society may by an ordinary resolutions passed by 3/5ths of the members present and voting for alteration of the bye-laws.

13. MANAGEMENT :

A Society shall have regd. office to which all communications and notices may be addressed. Any change of its registered office to a place outside the district in which it is registered shall be intimated to the Registrars of both the Districts.

14. DISQUALIFICATION OF MEMBERS :

- a) Not a major
- b) Unsound mind and stands so declared by a competent court
- c) Adjudicated as an insolvent or is an undischarged insolvent
- d) Disqualified for such appointment by an order of court
- e) As per rules of the Act and other reasons

15. SUITS :

- a) The Society shall sue and be sued in the name of the Secretary.
- b) Court Jurisdiction : All the legal affairs of the Society shall be settled in the jurisdiction of District Court, Eluru.

16. PROPERTIES :

The Properties movable or immovable vested in the name of the Society shall be represented by the PRESIDENT.

17. AUDIT :

The Annual accounts will be audited by Authorised Auditor by March every year and distribute the same among the members.

18. FINANCIAL YEAR :

Financial year means a period of 12 months from 1st April to 31st March of next year.

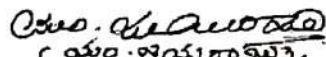
