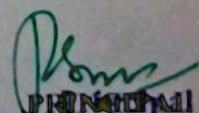
POLICY DOCUMENT ON GREEN AND PLASTIC FREE CAMPUS

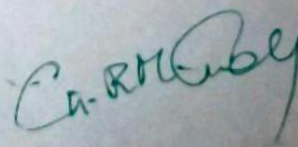
The important policy objectives are

1. To carry out annual Green Audit from time to time.
2. To develop an efficient Waste management system and Discard all branches of waste Material such as broken furniture, unusable equipment, etc on the campus.
3. To tap rain water by constructing rainwater harvesting pits.
4. To minimise air pollution in and around the college by using public Transport or pollution-free means of transport such as bicycles, battery powered bikes, etc.
5. To power off the monitors or to activate power management features of personal computers, laptops, tabs, mobiles and the likes so that the respective devices go into a low Power "sleep" mode when the devices are not in use.
6. To turn off monitors of the desktops when one leaves one's work desk and to turn off lights and use daylight Instead.
7. To avoid the use of decorative lighting & Use LED or compact fluorescent bulbs.
8. To keep Lights off in conference rooms, classrooms, lecture halls when they are not in use & Use the Fans only when they are needed.
9. To carry out timely maintenance of the electrical appliances such as fans, air conditioners etc. for the efficient usage of power.
10. To incorporate clean & green activities at least an hour a week in the academic schedule of the College.
11. To organise programmes that inculcate aesthetic sensitivity in student community viz. maintenance of green space on Campus by the Eco-Club of the college.
12. To carry out plantation programmes in the campus in association with government and other local bodies.
13. To encourage the use of public transport and car-pooling for minimizing the use of fuel consumption.
14. To conduct National and International Days of environmental significance viz. World Environment Day, World soil Day etc. in order to address the environmental issues including climate change.
15. To create awareness in the local community about efficient energy usage, environment protection and sustainable development.

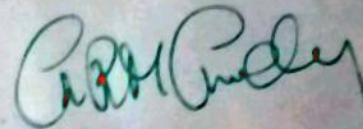
